All officers in the said cadres are requested to carefully verify the list and submit objections, if any. Objections/errors noted may be submitted through the respective Heads of Offices to the official email ID of the Senior Administrative Officer (ao.mvd@kerala.gov.in) within **7 days** from the date of publication of the draft list.

Objections must be submitted in the prescribed format as per **Annexure-I**, duly supported with relevant documents and / or citing applicable norms. Incomplete or unsubstantiated objections are liable to be summarily rejected.

All officers are also directed to verify their service history in SPARK through their respective establishments to ensure accuracy, as discrepancies in service history may affect the transfer process. Any such discrepancies must be reported along with the objections. The responsibility for reporting such discrepancies lies with both the concerned employees and the Heads of Offices / DDOs.

All Heads of Offices are directed to ensure that officers in the HA/HC/PRO

cadre are duly informed and instructed to verify the draft list published on the department's official website.

Note: Objections submitted after the deadline or in any format other than Annexure-I will not be considered under any circumstances.
