**ORDER NO: A4/30/2025-TC DATED 15-10-2025**

Four vacancies in the cadre of Motor Vehicles Inspector were kept reserved subject to the final outcome of the Ad hoc Departmental Promotion Committee (Lower) held in August 2025. In addition, one vacancy arose consequent to the retirement of Sri.Thomas Joseph, Motor Vehicles Inspector, Regional Transport Office,Thiruvananthapuram, on 31/07/2025, and another vacancy arose consequent to the promotion of Sri. Sivakumar S N, Motor Vehicles Inspector, as Joint Regional Transport Officer vide order read as 6<sup>th</sup> paper above. Hence, a total of six vacancies in the cadre of Motor Vehicles Inspector have arisen in the Department.

As per G.O.(Ms) No. 01/2019/Trans dated 04/01/2019, the Government have issued guidelines regarding the posting of AMVIs/ MVIs under the Safe Kerala Project. Accordingly, newly appointed/promoted AMVIs/ MVIs will be initially posted to the Enforcement Wing, and subsequently shifted to

offices based on their seniority. In order to accommodate the posting of those officers in the Enforcement Wing, the senior-most MVIs currently serving in the Enforcement Wing are shifted to the stations noted below:
