Order No.A3/123/2022-TC Dated. 07-12-2022

As per the order read above, the draft list for General Transfer - 2022 in the cadre of Assistant Motor Vehicles Inspectors has been published, calling for objections if any. The objections received have been examined in detail along with the service history and previous postings of the Officers, with respect to the norms for transfer prescribed by Government for the executive officers of the Motor Vehicles Department and the following transfer and postings of Assistant Motor Vehicles Inspectors are ordered with immediate effect.

The Hon'ble Kerala Administrative Tribunal, in its interim order read as 2nd paper above, has clarified that the pendency of OA No. 02/2020 and the interim order granted against the transfer of Shr. Anas S, Assistant Motor Vehicles Inspector, Sub RT Office, Tirur to Deputy Transport Commissionerate, Thrissur shall not stand in the way of consideration of the request of the applicant for transfer preferred by the applicant for General Transfer 2022. Shri. Anas S, Assistant Motor Vehicles Inspector, Sub RT Office, Tirur was transferred to DTC's Office, Thrissur on public interest, and not to the enforcement wing. He has already completed 2 years at the present station, which is the tenure fixed for an Assistant Motor

Vehicles Inspector at a station. Hence his application for transfer is considered as per his eligibility and transferred to his 1st option. Thus the order of the Hon'ble Kerala Administrative Tribunal read as 2^{nd} paper above is complied with.

As per the order read as 3rd paper above, the Hon'ble Kerala Administrative Tribunal has ordered as follows, "*In view of the fact that the applicant has preferred Annexure A11 objections to Annexure A10 draft transfer list, which is pending consideration, the original application is disposed of, directing the 2nd respondent to consider and pass appropriate orders on Annexure A11 objections, in accordance with law and General Transfer guidelines, taking note of the compassionate ground urged by the applicant, while finalizing Annexure A10 draft transfer list". The tribunal has pointed in the Para 5 of the interim order that he is eligible for a transfer on compassionate grounds and applicant has sought for transfer to Kollam or Thiruvananthapuram. Shri. Manoj Kumar TS has applied for transfer for compassionate grounds on 11.04.2022, stating his father is bedridden due to stroke and produced necessary medical certificate. In his online application, he has opted only for Kottayam and Kollam districts. His 1st option is Kottayam. Hence his application is considered and he is transferred to Regional Transport Officer (Enforcement), Kottayam under compassionate grounds. Thus the order of the Hon'ble Kerala Administrative Tribunal read as 3rd paper above is complied with.*

As per the interim order read as 4th paper above, the Hon'ble Kerala Administrative Tribunal has ordered as follows, "In view of the submission that the General Transfer proceedings have commenced in the department and the applicants have all exercised their options for transfer, it is made clear that issuance of Annexures A8 & A9 orders by the 1st and 2nd respondents shall not stand in the way of consideration of their applications if they are other wise eligible for the same". Shri. Jayakrishnan D S, Shri. Vishak B Pillai, Shri. Sujith R, Shri. Baby Joseph, Shri. Sibi S, Assistant Motor vehicles Inspectors were transferred to the Enforcement wing on public interest. Shri. Vishak B Pillai, Shri. Sujith R and Shri. Baby Joseph have joined to Enforcement wing, while Shri. Jayakrishnan D S and Shri. Sibi S are still working at RTO, Thrissur.

The Hon'ble Supreme Court Committee on Road Safety, chaired by Justice Abhay Manohar Sapre has directed that the state government should take all measures as are necessary for reduction of road accident fatalities. The Committee has directed that the state would strictly enforce provisions of the Motor Vehicles (amendment) Act, 2019 relating to disqualification and revocation of driving licenses in respect of Two wheeler and LMVs for over speeding and non-wearing of helmets on Expressways, National/State Highways and other straight roads in rural/open areas . The Committee has also directed that the state would augment man power and equipment for effective enforcement so as to reach Bureau of Police Research and Development norms.

The Division Bench of the Honorable High Court of Kerala in the judgement dated 23.06.2022 in WP (C) No. 11644/2022 has made it clear that every step and action shall be taken by the Transport Commissioner to ensure that the provisions of the Road Safety Act, 2007 are implemented in its letter and spirit and that the State and the Transport Commissioner shall not forget the fact that the Kerala Road Safety Authority Act, 2007 is constituted in order to ensure road safety, reduce accidents avoid injuries and fatality. The writ petition was disposed of directing the Transport Commissioner to ensure that the Enforcement Officers are put back to their Enforcement duties at the earliest. Thus as per the above directions of the Hon'ble High Court, the enforcement Officers are to be put back to enforcement duties.

In the above circumstances, their applications are considered as per their eligibility and the requirement of officers in the Enforcement Wing to comply with the directives of the Hon. High Court of Kerala. Thus the order of the Hon'ble Kerala Administrative Tribunal read as 4th paper above is complied with.
