MEMORANDUM

Sub:- Transport Department - Establishment - request to refix the seniority in r/o Sri.Shibi.T.J, Motor Vehicles Inspector - Objection called for - reg:-

Ref:- 1.Representation dated 30.12.2019. submitted by Sri.Shibi.T.J, Motor Vehicles Inspector  
2.Letter No.A2/62/2020-TC dated.23.04.2020.

Inviting attention to the reference cited above, I am to inform you the following:-

Sri. Shibi. T. J was not included in the rank list published by KPSC on 06.12.2005 for the post of AMVIs due to a mistake on the part of KPSC regarding his experience. Subsequently, based on his request, KPSC included him in the rank list by an addendum notification dated 23.03.2006. He was placed between rank No. 49 and 50 as rank No.49A. Meanwhile, a large number of candidates placed below him in the rank list had already been advised. Sri. Shibi. T. J was advised on 23.06.2006. His contention is that rank No.49 in the rank list was assigned a seniority of 161 in the seniority list for the post of AMVIs and rank No.50 was assigned the seniority of 170. He being rank No.49A was assigned a seniority of 199 instead of a position between 161 and 170. He has requested to assign his seniority in the seniority list for the post of AMVIs, as per his rank number in the rank list for the post of AMVIs.

The request of Sri.Shibi. T. J was earlier rejected by the KPSC, informing that his inclusion in the rank list was through addendum notification without disturbing those who had already advised from the list and he was advised as out of turn against a vacancy arised later. Hence informed that he was not eligible for seniority according to rank number and only eligible for seniority as per advise.

As per the letter dated 04.12.2014, KPSC further informed that Sri.Shibi.T.



J would have been advised as Sl. No.78 in the advice list of 103 candidates advised on 17.05.2005, had he been advised based on his revised rank position. In other words, had he been duly advised based on his assigned rank position in the list, he would have been eligible to get seniority in the cadre of AMVI corresponding to the said position of Sl. No.78 in the advice list.

His request to refix his seniority has been examined by Government earlier and rejected it vide GO(Rt)No.35/15/Tran dated 20.01.2015 and also directed the TC to issue appropriate orders specifying his seniority based on the advice of the KPSC dated 04.12.2014.

The applicant has been deprived of his legitimate seniority for a fault not of his own. Keeping in view of this aspect, Government have tentatively decided to assign his seniority in the appropriate place in the seniority list of AMVIs based on the advice position cited in the letter of the KPSC dated 04.12.2014 by invoking Rule 39 of Part II KS&SSRs after issuing notice to the affected parties.

Therefore you are requested to file objections ,if any, in this regard before the Under Secretary, Transport (C) Department within 15 days from the date of receipt of this communication.. Further if you seek a personal hearing in the matter ,the same may also be intimated to the said officer within the above said period. If nothing is heard from you in this regard within the above said period, action will be proceeded in the assumption that you have no objection in the matter.
