**Order No. A3/134/2021-TC Dated. 19/03/2022**

Consequent to the retirement of Smt. Mayadevi C, Junior Superintendent, Regional Transport office, Pathanamthitta, a vacancy in the cadre of Junior Superintendent arose in the Motor Vehicles Department. Smt. Sakunthala N, Head Accountant is the senior most person in the cadre of Head Accountant/Head Clerk/ Public Relations Officer, as per the Seniority List published vide order read above. Smt. Sakunthala N was awarded a punishment by barring one increment for six months without cumulative effect, as per G.O (Rt) No. 57/2022/Trans dated 15.02.2022. As per rule 28 (b) (ii) of the KS&SSRs, "All other promotions or appointments by transfer to higher posts shall, subject to the provisions of these rules and the special rules, be made in accordance with seniority subject to the person being considered suitable for the post. Punishments other than censure awarded within a period of three years immediately preceding such promotion or appointment by transfer shall be taken into account in determining the suitability of a person for promotion or appointment by transfer. As such Smt. Sakunthala N cannot be considered for promotion during the currency of the punishment period.

Hence, Smt. Ranju Mahendra, Head Accountant, Sub Regional Transport Office, Thrrippunithura, who is the next senior most person in the cadre of Head Accountant/Head Clerk/ Public Relations Officer, is promoted as Junior Superintendent in this Department in the scale of pay ₹ 43400-1100-47800-1200-52600-1300-56500-1400-60700-1500-65200-1600-70000-1800-79000-2000-89000-2200-91200 under Rule 28(b) (ii) of the General Rules of Part II, KS & SSRs, subject to the outcome of O.As/W.Ps/W.As, if any, pending before the Honorable Kerala Administrative Tribunal/Courts.
