## ORDER NO.A5/3344/2016/TC Dated: 21/06/2016

As per the G.Os read as 1st and 2nd papers above General Transfer norms for transfer and postings of various categories of employees of the Motor Vehicles Department have been issued by the government. According to which the employees who Employees who have not completed three years of duty in a station shall not ordinarily be transferred. However, an employee may be allowed to continue in a station even after three years, if there is no applicant for transfer to that station. In certain circumstances when an employee comes to definite adverse notice of Government as far as his work is concerned, he may be transferred from his station even before completion of three years. Last Grade Employees shall be posted in their native District or District of their choice, as far as possible. There shall be no general transfer of Last Grade Employees.

Accordingly, notification for general transfer of various categories of employees of this department has been formalized as per the Circular read as 3<sup>rd</sup> paper above. The applications so received have been processed and a provisional list of employees to be considered in the General Transfer 2016 in the category of Typists is appended herewith. Those who have completed 5 years of tenure in the present station shall be shifted from the present station under the administrative exigency even though they are not filed their request for transfer from the present station. All Head of Offices are directed to circulate the list among the employees working in the category of Typists working under their control. Objections, if any, received from the employees should be forwarded to this office on or before 25/06/2016. Final list will be published on or after 27/06/2016. Belated objections/requests/representations received after the stipulated time of 25/06/2016 will not be considered on any account.

Detailed transfer norms of employees ordered as per the G.Os read as 1<sup>st</sup> and 2<sup>nd</sup> papers above are also appended herewith for information of the employees concerned.
