## ORDER NO.A3/9377/2016/TC, Dated, 4.1.2018

Due to the promotion of 5 Junior Superintendents to the cadre of Senior Superintendents, 5 vacancies of Junior Superintendents have occurred in this Department. The following seniormost Head Clerks/Head Accountants/Public Relations Officers, as per the final Seniority List read above, have been considered for promotion to the cadre of Junior Superintendent.

- 2) Out of the above officers, Sri.C.P.Sakaria, Smt.Mayadevi, Smt.C.V.Manjula, and Sri. A.Jose, were earlier excluded from promotion due to the pendency of disciplinary proceedings for major penalty under Rule 15 of KCS(CCA)Rules against them. Against the exclusion from promotion, Sri.C.P.Sakaria and Sri.A.Jose had filed OA No. 2121/2017 and 2034/2017 respectively, before the Hon'ble Kerala Administrative Tribunal, and Hon'ble KAT directed to consider them for promotion, as per interim orders dated, 10.11.2017 and 27.10.2017 respectively. Probation of Smt.C.V.Manjula has not been declared yet due to the pendency of Vigilance Case. The orders of the Hon'ble Kerala Administrative Tribunal have been examined on the basis of the relevant statutory provisions. Smt. C.V.Manjula is excluded from promotion due to the pendency of Vigilance Case against her and for the non-declaration of probation in the feeder category.
- 3) Sri. C.P.Sakaria, Smt.C.Mayadevi, Sri.A.Jose, Sri.K.Vinod Kumar and Smt.P.Priya, in the cadre of HA/HC/PRO, are promoted to the cadre of Junior Superintendent in this Department in the Revised Scale of Pay Rs.30700-65400 under Rule 28(b) (ii) of the General Rules of Part II, KS & SSRs, subject to the decision in the O.Ps/W.Ps/W.As, if any, pending before the Honourable Kerala Administrative Tribunal/Courts. Promotion in respect of Sri.C.P.Sakaria, Smt.C.Mayadevi and Sri.A.Jose are provisional subject to the final disposal of the disciplinary action pending against them.
