Sub: *Motor Vehicles Department – Estt* - Final Seniority List of Motor Vehicle Inspector as on 01/01/2016 –Revised – Orders Issued.

**ORDER NO.A6/E 3568/TC/2016 Dated 28/04/2017**

- 1). As per the order read above the final Seniority List of Motor Vehicle Inspectors as on 01.01.2016 was prepared in accordance with the General Principles, norms and provisions in Kerala State and subordinate Service Rules 1958 and published in the Kerala Gazette.
- 2). It was also circulated among the officials for information to the concerned. The list was uploaded in the official website of Motor Vehicles Department “www.keralamvd.gov.in”.
- 3). Pursuantly, ten Motor Vehicle Inspectors have filed following objection against their seniority assigned in the final seniority list.
- 4). Sri.B.L Satheesh Kumar, MVI has filed an objection that his seniority in the select list published on 14/11/2012 has been revised by the DPC held on 22/02/2013 and as per the approved select list published on 05/03/2013 , his seniority has been assigned between Sri.V. Mohandas and Sri. Reji George. Hence he requested to reassign his seniority as Sl.No.122 in between V.Mohandas and Reji George.
- 5). Sri. Ajith Andrews MVI has filed an objection that his seniority in the select list published on 16/03/2013 has been revised in the adhoc DPC held on 10/09/2013 and as per the select list published on 28/09/2013, his seniority has been assigned between Sri. M.K Prajeesh and Sri. Arun Kumar



S.M. Hence he requested to reassign his seniority as Sl.No.164 in between Sri. M.K Prajeesh and Sri. Arun Kumar S.M.

6). Sri. N.R. Rajan, MVI has filed an objection that due to the disciplinary action pending against him he was not considered for promotion during the DPC held on these period, and his just junior has been promoted on 04/09/2008. On 05/12/2008 as per G.O.(Rt)No.426/2008/Trans dated 05/12/2008, he was exonerated from the charges and he was promoted as MVI only on 31/05/2010. But in the DPC held on 07/03/2011, the select list published on 11/03/2008 has been revised, and his seniority has been placed in between Sri. Roy Thomas and Sri B Binod Krishnan. Hence he requested to reassign his seniority accordingly.

7). Sri. Koshy George, MVI has filed an objection that the DPC held on 22/02/2013 has revised the select list published on 25/02/2012 and assigned his seniority in between Sri. Narayanan Unni V.A and Sri. R. Reghunath as Sl No.5(a). Hence he requested to revise his seniority accordingly.

8). Sri. Jyothikumar.D, MVI has filed an objection that in the order dated 30/09/2016 in OA No. the Hon'ble Kerala Administrative Tribunal directed the 1<sup>st</sup> respondent the Secretary Transport to consider his request to restore his seniority w.e.f. the date of his immediate junior Sri.Raju.K.R.

9). Sri. S. Sreejith, MVI has filed an objection that on finalization of disciplinary action initiated against him by awarding a 'Censure', the DPC held on 04/06/2013 reviewed the select list published on 05/03/2013 and revised his seniority just below Sri.Renjithmon.T. Hence he requested to reassign his seniority accordingly.

10). Sri. E.C Pradeep filed an objection that pursuant to the order dated 02/06/2014 in OA No. 680/2013 of the Hon'ble KAT, the adhoc DPC held on 06/11/2014 revised the select list published on 11/06/2014 and set a



condition that he is eligible for promotion only against the vacancy that will arise after 05/06/2014. Later he was promoted on 28/04/2015. But his immediate junior Sri.V.S.Ajithkumar was promoted on 31/12/2010. His request is to assign his seniority above Sri. V.S Ajithkumar.

11). Sri. Biju Issac filed an objection that as per the select list published on 21/03/2011, he is placed as 15(a) in between Sri. Abdul Zubair M.P and Sri.C. Padmakumar. Hence his seniority is to be assigned accordingly.

12). Sri. Malik.S has filed an objection that due to the disciplinary proceedings initiated against him, his promotion has been delayed. The disciplinary action initiated against him has been finalized by awarding a punishment of barring one increment for one year without cumulative effect w.e.f 28/07/2011. After that he was promoted as MVI on 15/06/2013. Thus in the seniority list he was superseded by 13 juniors. Since the punishment awarded to him is without cumulative effect and the punishment period was expired on 27/07/2012, he requested to refix his seniority accordingly.

13). These objections were examined in detail and the relevant changes are effected on the basis of rules in force as follows:

- 1) The Seniority of Sri. B.L Satheesh Kumar is fixed in between V. Mohandas and Reji George as Sl.No. 122
- 2) The seniority of Ajith Andrews is fixed in between M.K Prajeesh and S.M Arunkumar as Sl.No. 165
- 3) The seniority of N.R Rajan is placed in between Roy Thomas and B Binod Krishnan as Sl.No. 33
- 4) The seniority of Koshy George is fixed above R.Reghunath as Sl.No.94



- 5) The seniority of S. Sreejith is fixed below Renjithmon.T and C K Ajilkumar and as Sl.No. 148
- 6) The seniority of Malik.S is fixed in between K.R Prasad and B.K Sudeep as Sl.No. 178.

14). The case of Sri. Biju Issac has been referred to Government for clarification and on the basis of the Government decision his request will be considered.

15) The representation of Sri. E.C Pradeep can not be considered because DPC held on 06/05/2014 considered his promotion only to the vacancy arising after 05/06/2014.

16) The request of Sri. Jyothikumar.D will be considered based on the government decision in compliance with the order dated 30/09/2016 of Hon'ble KAT in OA No.892/13.

17). More over as per the reference 2<sup>nd</sup> cited the date of promotion of the C.Sunilkumar has been revised to 14/11/2007, the date on which his immediate junior Sri.Jebi I Cherian was promoted as MVI. Hence the seniority of C.Sunil Kumar is assigned as Sl.No. 19 in between B Saju and Jebi I Cheriyan.

18). In accordance with the objections found to be genuine, necessary modifications were effected and the final seniority list of MVIs as on 01/01/2016 published as per reference 1<sup>st</sup> cited is revised accordingly. The list is appended here to as Annexure I and publish for information of all those concerned.




