**ORDER No. A2/20294/2017/TC, dated, 27.2.2018**

As per letter read as 1<sup>st</sup> above, Government have directed to transfer 5 Clerks/Senior Clerks in the Regional Transport Office, Attingal out of Thiruvananthapuram District, on the basis of the inspection report of Personnel & Administrative Reforms (Administrative Vigilance) Department. As Clerks in entry cadre were included in the list, clarification was sought from Government regarding inter-district transfer of the officers involved. But Government, as per letter read 2<sup>nd</sup> above, have re-iterated that the officers involved are to be transferred out of the district.

As per G.O read above, Government have reinstated the Senior Clerks, Sri.S.Sanjeev and Smt.Soji Hentry, of R.T.Office, Attingal from suspension and directed to post them in a non-sensitive post out of Thiruvananthapuram district. Accordingly the following transfer and postings of Clerks/Senior Clerks in the Motor Vehicles Department are ordered with immediate effect. The transfers made in this order will be subjected to change as per norms during the General Transfer 2018.
